RE: Exhibitor / Vendor Welcome Letter and Event Application Information

Dear Tournament Exhibitor / Vendor:

Thank you for your interest in being an exhibitor or vendor at Beach Soccer Jam.

As you may be aware, Beach Soccer Jam is much more than a soccer tournament, it is an event that is filled with exciting activities, entertainment and lots of fun. This year's event starts on Saturday, May 20th, 2017 and ends Sunday, May 21st, 2017 in the early evening.

If you are interested in participating as an exhibitor or vendor at this year's Beach Soccer Jam event, we will need the following items from you:

1. Completed Vendor / Exhibitor Application (Please read carefully when completing)

 - c. Vendor / Exhibitor Application Part II - available online: [click here](#)
2. Certificate of Insurance (as listed in the Vendor / Exhibitor Application)
 - a. Must be submitted together with the Vendor / Exhibitor Application
3. Food Facility Permit / Health Permit (as listed in the Vendor / Exhibitor Application)
 - a. **This permit is only required if you are selling food.**
 - b. Statement of confirmation that as a permitted vendor, you will provide or be approved by Beach Soccer Jam to share and use a County of San Diego approved 3 compartment sink and a 2-A: K Class K fire extinguisher in addition to a 2-A-10B: Class C rated portable fire extinguisher.
 - c. Statement of confirmation that as a permitted vendor, you will provide and use sufficient flooring (canvas, etc.) to prevent spillages from contaminating the ground.
4. Vending Fees and Deposits
 - a. The Vending Fee is 15% of Gross Sales (with minimums) fully due and payable on the last day of the event.
 - b. A deposit of \$425 is required for standard food vendors, \$1,000 for premium food vendors, \$350 for merchandise vendors, \$300 for exhibitors (no sales), \$250 for Craft Type Vendors and Non-Profits. Vending Fee Deposits must be submitted with the Exhibitor / Vendor Application in order for the application to be considered. Once approved, the deposit is not refundable.
 - c. An additional fee of \$40 applies to food/beverage vendors who do not have their own 3 compartment sink as required by the San Diego County Health Department. This helps cover our rental costs for providing one.

Please email any questions to Rick@BeachSoccerJam.com. Applications are reviewed upon receipt for completeness and potential vendor conflicts, so sending properly completed applications early is important in helping secure a vendor booth.
